First, changing introduction is required to remove duplication in whole thesis. Some information of the material is duplicate and it is required to modify for the thesis.

And, I want to delete unnecessary parts (such as too much information for the coherency in the dissertation or to minimize coauthor's work). Since the dissertation should be more detailed, I want to add more sentences to justify my research if possible. Please let me know.
